1. Commercial Hosting Migration Complete

On April 14, ARC successfully migrated our shared environment of Oracle, Discoverer, and PRISM applications to Oracle On Demand's hosting services. This also included an upgrade of Oracle and Discoverer software for these customers. Over the past many months, we have shared our plans with our customer agencies and provided them with opportunities to participate in both user testing and training. This successful migration completes the initial phase of ARC's migration to Oracle's hosted platform.

### 3. IT Staff Presents at ISSLOB Conference

Representatives of ARC's Information Technology group presented at the April 15 Information Systems Security Line of Business (ISSLOB) conference at the NTSB Conference Center in L'Enfant Plaza. As one of the four Shared Service Centers under the ISSLOB, the group presented to a variety of Federal agencies interested in obtaining Certification and Accreditation (C&A) services.

### 4. Fiscal Year 2009 Funding

On March 11, 2009, the President signed into law a \$410 billion omnibus appropriations bill to provide FY 2009 funding for the remaining Federal departments and agencies not included in the continuing resolution (Public Law 110-329) that funded Government programs at FY2009 levels through March 6, 2009. ARC has informed contractors of this event. With this approval coming so late in the fiscal year, we realize that you have a compressed time schedule to spend these dollars. Procurement team leaders are eager to assist you with acquisition planning and the processing of your FY 2009 procurement actions. Please see last month's ARC Bulletin for the due dates for the submission of your forecasts and procurement packages. ### 5. New Functionality and System Improvements for PRISM on the Way

Users in our shared environment will see new functionality and system improvements with the upgrade of PRISM to version 6.3, which is anticipated for implementation on Sunday, May 17, 2009. Significant improvements include the ability to post PRISM records into the latest version of the Federal Procurement Data System – Next Generation (FPDS-NG) and an increased number of data elements passed to FPDS-NG.

### 6. FTR Provides Agencies With Option To Cap Home Values Under Guaranteed Home Sale Program

For customers who offer Guaranteed Home Sale (GHS) services, the Federal Travel Regulation (FTR) authorizes agencies the option of setting a maximum home value, above which it will be the employee's responsibility to cover the costs. This is not a new provision in the FTR, but it is one that agencies may want to consider in light of increased GHS vendor rates and increased scrutiny of the program.

FTR §302-12.111 covers this area and sets forth factors to consider when establishing the maximum home value.

### 7. Form 1099 Recordkeeping Tips

ARC submitted 5,769 IRS 1099 tax forms for calendar year 2008 before the March 31 filing deadline on behalf of our 29 customer agencies. A convenience check log, 1099 record keeping tips, and instructions are provided to convenience check holders when they receive their checks. Reminder emails are also sent periodically to ARC's 1099 contacts.

#### 8. Elimination of Time-in-Grade Delayed

As indicated in the January ARC Bulletin, the Office of Personnel Management (OPM) issued final regulations to eliminate the 52-week time-in-grade requirement for promotions in the General Schedule effective March 9, 2009. Due to the January 20 White House Memorandum on regulatory review, the elimination of time-in-grade has been delayed until May 18, 2009.
