### 3. PAWS scheduled for production in August

We are excited to announce that the Classification and Recruitment Reporting System (CaRRS) replacement system, Personnel Action Workflow System (PAWS), is scheduled for production between mid-August through September. PAWS is a Business Process Management (BPM) application that will assist us in building more effective and efficient processes, improving quality and service, and providing clients with more frequent staffing and classification statuses, including more detailed transaction progression. ## 4. Concur Government Edition (CGE) implementation

We will begin a pilot of CGE, the travel system that replaces GovTrip, in July, 2013. Beginning in September, we plan to begin migrating customers to CGE with all customer migrations completed by May 2014. Although the GovTrip contract expires November 11, 2013, a two year extension is in place to provide additional time for agencies to migrate to the CGE system.

5. Fiscal Service Signs Treasury's Domain Name System Security Extensions (DNSSEC) In August 2008, OMB issued Memorandum M-08-23 instructing Federal Government entities to implement Domain Name Systems Security Extensions (DNSSEC) for all .gov domains. Treasury chose Fiscal Service to implement this service to all Treasury bureaus, minus the Internal Revenue Service (IRS), due to the existing capabilities within the infrastructure. Prior to the transition to Fiscal Service in July 2012, Treasury had 133 .gov domains registered with only 23 domains, or 18%, compliant with the DNSSEC mandate. Following the initial migration, 30 additional commercially-hosted domains were identified that needed to be signed. Beginning in May 2013, we worked with the Treasury bureaus and the external hosting entities to sign these remaining .gov domains to Fiscal Service. As of today, the majority of domains have been moved to Fiscal Service bringing the Treasury compliance score to 95%. We plan to sign the remaining domains in the near future and bring the department to full compliance with OMB.
