# 2. Changes in email Domain for Financial Management Services (FMS) and the Bureau of the Public Debt (BPD)

This is an exciting change in our next step to identify ourselves as Fiscal Service. #### 3. Budget Object Class Listing for Fiscal Year 2014

After the release of the OMB Circular A-11, our Budget group has reviewed and updated the Budget Object Class listing for Fiscal Year 2014. Several modifications were made to existing codes relating to moving expenses, real estate transactions, relocation, capital lease for ADP equipment and various other codes. In addition, there were three new codes added: GSA law enforcement vehicle mileage usage lease cost, household goods – taxable and GSA law enforcement vehicle monthly lease cost.

# 4. Electronic Official Personnel Folder (eOPF) Conversion Completed

OPM's initiative to convert all paper Official Personnel Folders (OPF) to electronic format is nearing completion for all Fiscal Service human resources customers. Over the past several years, Fiscal Service has been facilitating the multi-phase process of converting over 15,000 OPF's into electronic format. In January 2014, the following bureaus -- United States Mint, Bureau of Engraving and Printing (Western Currency Facility), Alcohol and Tobacco Tax and Trade Bureau, and Treasury Inspector General for Tax Administration -- will "go live" thus completing the final phase of the process. Employees of those agencies will be receiving additional guidance and instruction on accessing their eOPFs.
