1. New ConcurGov Attachment and Receipt Enhancement

Concur is updating the attachment and receipt functionality in the ConcurGov travel system. This change will allow users to attach receipts directly to individual expenses as well as attachments to the main summary page. January 15, 2018 is the scheduled release date for the enhancement. However, because of the Federal holiday, users may not see this enhancement in ConcurGov until January 17th.

Prior to this enhancement, the system combined all uploaded receipts and images into one PDF. Users were unable to view or delete individual items.

With the new Attachments & Receipts Enhancement:

- Up to four attachments can be uploaded to a travel expense (Expense Module)
- Up to ten attachments can be uploaded to a travel document (Main Summary Page)
- Max size of 5MB per file
- Five file extensions are supported: gif; jpg; pdf; png; and tiff
