3. HRConnect Update

Effective Monday June 29th, Treasury's HRConnect application will be updated with some User Interface/ User Experience (UI/UX) enhancements. The enhancements will provide HRConnect with a more modern and responsive user interface and create a baseline platform to adopt more delivered Oracle functionality.

Incremental usability improvements will be delivered over multiple phased releases. The first phase includes establishing the Fluid framework in HRConnect. The Fluid framework includes updates to HRConnect homepage, banner, navigation, creation of Fluid homepage tiles, and creation of Navigation Collections and tiles for users with elevated roles. This change is also a step toward the future ability to access HRConnect on mobile devices.
