1. Unique Entity Identifier (UEI) Update

We successfully implemented UEI in Oracle, PRISM, and other subsidiary systems on 3/13/2022. During implementation ARC staff populated the UEI field at the supplier site level for all active suppliers as well as interfaced the UEI to appear in PRISM. UEI will be used as the supplier number for new suppliers requested by customers starting on 3/14/2022. Existing supplier numbers will not be changed. OBI users who have built custom reports utilizing the DUNS or DUNS+4 data elements will need to edit those reports to pull in the new UEI value instead. All SAR reports have already been updated to include UEI.

5. Announcing the NEW and IMPROVED Dynamic Supplier Entry form!

DUNS will no longer be available in the System for Awards Management (SAM.gov) after 4/03/2022 and can no longer be used to submit new Supplier Requests. Instead a Unique Entity Identifier (UEI) has been issued and is currently in SAM for all existing Supplier records. New suppliers can request one for free at SAM.gov.

To accommodate this change the Vendor Supplier Group (VSG) in collaboration with the Graphics, Printing and Imaging group is pleased to announce the NEW and IMPROVED Dynamic Supplier Entry form! The form helps Customers provide what is needed by opening the required fields based on choices you make in the form.

This form along with Instructions and Frequently Asked Questions is available on your Customer Access page under forms. Or you can receive it upon request from VendorSupplierGroup@fiscal.treasury.gov.

6. oneARC Portal is Live!

We are excited to announce that the oneARC Portal has gone live! Real-time budget transactions are occurring in the Portal. If your agency hasn't gone live yet – don't worry, we are scheduling additional rollouts. We look forward to including all agencies soon.
