2. New Supplier Request Form

DUNS will no longer be available in the System for Awards Management (SAM.gov) after 4/03/2022 and can no longer be used to submit new Supplier Requests. Instead a Unique Entity Identifier (UEI) has been issued and is currently in SAM for all existing Supplier records. New suppliers can request one for free at SAM.gov.

To accommodate this change the Vendor Supplier Group (VSG) in collaboration with the Graphics, Printing and Imaging group is pleased to announce the NEW and IMPROVED Dynamic Supplier Entry form! The form helps Customers provide what is needed by opening the required fields based on choices you make in the form. This form along with Instructions and Frequently Asked Questions is available on your Customer Access page under forms. Or you can receive it upon request from VendorSupplierGroup@fiscal.treasury.gov.

4. PRISM Insight: One Giant Leap Forward

PRISM upgrades are underway! ARC's Division of Procurement Services has started the exciting work toward upgrading the PRISM contract writing system to include the Insight Platform and two important applications. First, we plan to introduce PRISM 7.5, which will provide improved analytics and dashboard display options. However, we aren't stopping there. Around the end of the calendar year, we plan to roll out PRISM's Insight platform with the Data Validation and Accelerator applications bringing even greater tools to improve the user experience.

In recent customer engagement surveys and meetings, you told us that you wanted greater status visibility, increased access to data and documentation, enhanced quality and compliance, and real-time contract management. This PRISM upgrade will give you improved analytics, dashboard displays, automated error-proofing, document routing, and status reporting at your fingertips.
